4 AREAS of PSR's WORK



RESPONDING TO CONCERNS

PSRs are the first point of contact for the parish community should they wish to disclose a safeguarding concern hence the PSR is responsible to check their dedicated SG email address on a regular basis and at least once a week. Should PSRs become aware of any concern they have to pass this on to the central safeguarding team within the first 24/48 hours of learning about the concern. This is a vital area of work in order to assure an appropriate response to anyone in need of support. The email address can also be set up on the PSR's mobile phone as long as this is secured with safety access codes at all times to enhance third parties' data protection.

SAFE RECRUITMENT

The process of securely recruiting anyone who wish to work/volunteer in the parishes with groups of vulnerable like children and/or adults at risk. This process includes the initial processing of DBS applications including ID verification, interviews, and reference requests for example.

CREATING A SAFE ENVIRONEMNT

An incredibly important part of a PSR's work to be carried out with the collaboration of parish priests, activity group leaders, parish admins and any volunteer in contact with vulnerable groups. It is about knowing and implementing both safeguarding policies and procedures whenever a parish activity especially for children and/or adults at risk takes place. CSAS (Catholic Safeguarding Advisory Services) is the web site to visit and the guidance "Creating a safer environment" should be a central piece of this work with which every person working/volunteering at the parish should be familiar with. • ADVANCING A "CULTURE OF SAFEGUARDING"

This part of the work aims at educating the parish communities with a basic understanding of what safeguarding means and does to keep everybody safe from harm and abuse. PSRs should encourage the community to enrol in SG EduCare online modules by contacting Mr Gabriele Sedda at gabrielesedda@rcdow.org.uk to be registered and start/complete these safeguarding courses. Also safeguarding literature should be regularly distributed in the parish. This ranges from leaflets to support survivors of abuse to Alpha Cards to recognise and responding to abuse and more. A so called "safeguarding corner" in the parishes consisting of a small table to keep the literature would be ideal.

All concerns must be brought to the Safeguarding Representative, who in turn will contact the diocesan Safeguarding Coordinator. Never delay taking action. If you are unable to contact the Safeguarding Representative and/or Coordinator you can contact the Catholic Safeguarding Advisory Service (CSAS) if you require advice

Changes to the enhanced DBS check application process

Please see below for an update from DBS re the application process. As shown applications will be withdrawn if there are any errors or omissions therefore it is very important that we check the information submitted carefully at the ID verification stage to ensure that all names (specifically middle and previous name) are declared, and the applicants full 5-year address (including flat numbers) history is declared.

As of 31 May 2021, the Disclosure and Barring Service (DBS) will be implementing a change to the enhanced DBS check application process. The change will mean that DBS is no longer able to amend an applicant's personal information on the application form, once it has been submitted.

For Registered Bodies

If incorrect personal information is provided, or an omission is identified, in relation to the below sections of the application form, from 31 May 2021, the application will be withdrawn, and a new application will be required:

- Section A Your current and previous names
- Section B Your current address
- Section C Five-year address history

For RBs, as before, DBS will contact you to resolve the query, and only if an error or omission is confirmed, will the application be withdrawn.

If an application is withdrawn for the above reasons, a refund will not be given.

Where such an error is found, DBS will not contact the applicant, but will instead write to you as the Registered Body that submitted the enhanced application.

CREATING A SAFE ENVIRONMENT:

Campaign: Safeguarding Sunday

Description:

Safeguarding Sunday is a national campaign which co-ordinated by Thirtyone: eight to raise awareness and understanding of safeguarding within all UK churches by resourcing them to effectively communicate the need for safeguarding within their own congregations, and to highlight and celebrate the things they are doing to create safer places for all so that people can feel, and be, safe.

Vision:

We want to see every church in the UK committed to creating safer places through the implementation of good safequarding practice.

Campaign goals:

- For every church in the UK to join together throughout October and November to dedicate a Sunday service to focus on safeguarding and commit together to create safer places for all.
- For church attendees of all ages to gain an understanding of what safeguarding is and why it's important, how it fits with Christian teaching, the things their church is doing to make it a safer place; and to know who they can go to within the church with any concerns.
- To bring balance to the largely negative public narrative and image of safeguarding in churches by sharing and promoting the many positive stories of good practice and healthier cultures that are being created with local and national media.

Key activities:

- To make available a range of digital and print resources to equip local churches across all traditions to hold a
 Safeguarding Sunday service on the second Sunday in October (or a date or their choosing) that is themed
 around the topic of safeguarding including: Prayers, videos, song ideas, activities, preaching plans and
 children's activities etc.
- To equip churches to engage local media and to communicate to their local community about the things they have in place.
- To promote and advertise the campaign nationally so churches feel they are connected and taking part in something bigger than themselves.
- To engage national press and media in sharing good news stories and examples of how churches are getting safeguarding right.

Target audience:

All UK churches (via their safeguarding lead) and the wider public.

Campaign impact to date:

The campaign has run for two years in 2019 and 2020 and to date has had around 700 churches signed-up. We'd like to see this grow to every church in the UK taking part. Here is a selection of the feedback we have received so far:

"I've had several people comment to me after Safeguarding Sunday saying it had been helpful to remind them of all our responsibilities, mentioning things they had learnt that had not occurred to them before, and two people came to me to talk about abuse they had experienced as children!"

"Children got to talk about possible situations where they'd need to talk to a grown up. Adults were reminded about their part in keeping vulnerable adults and children safe in our church."

"People told me that hearing about safeguarding helped them to understand more and showed them how they could be included in shaping the safeguarding policy." One church shared that "Safeguarding is really being pushed forward within our Church at present and it is great that we are able to bring everyone on board by holding the Safeguarding Service, so that we feel we really are making it 'everyone's responsibility' and creating a safe environment for all' Another church Safeguarding Coordinator shared that after holding a Safeguarding Sunday service "two people came to me to talk about abuse they had experienced as children." That's two more people getting the help and support they need because of this campaign.

Frequently asked questions

Questions:

Q: Do we need to DBS our parish administrator?

Q: Any DBS queries?

- Q: We are renting our hall to an irish dancing group however, their SG policies and proceudres are not completely satisfactory, what shall we do?
- Q: Can we now allow funerals with as many people as possible?
- Q: I have submitted a DBS application some time ago but have not yet received notification about its progression.
- Q: I would like to have some help in my role as PSR as I may not be at the parish all the times, how can we find someone suitable?

- A: Please refer to the HALL HIRE AGREEMENT issued in February that your parish priest can also find on the priests' resource centre. In the agreement, chapter 15. Safeguarding will address all the safeguarding requirements needed prior to the start of activities by an external organisation/group/club working with children/young people or adults at risk in a parish rented hall. If still in doubt where to find the document or for any additional support, please contact Arianna.
- A: Please do continue to follow government Covid-19 guidance on funerals and other activities in and around parishes until all the restrictions are officially lifted by the government. - A: The PSR and parish priest can advertise the PSR's role in various ways: on the newsletter, with short talks to the community after mass, on social media pages if the parish has these, by word of mouth, on the parish website. SAFEGUARDING NEWS

National Changes:

CSAS has now changed to the Catholic Safeguarding Standards Agency – CSSA. They have appointed a Board which is being chaired by Mr Nazir Afzal. Dr Colette Limbrick has been appointed as the Chief Executive Officer and has explained that '...This enables the CSSA to adopt the current national policies and procedures etc until such time that it is ready to implement the new standards and introduce new procedures where necessary. Between now and the autumn, the CSSA will continue developing its operations and the tools that will support the church bodies that contract with it in due course. Integral to this work is the development of new information sharing agreements that will enable the church bodies to work together in the interests of protecting people'.

The aim is for the CSSA to produce a set of National Standards against which we can self evaluate, and will be audited by the CSSA; we await the publication of the standards.

Ending of the Alignment agreement with Religious Orders:

The implementation of the Elliot recommendation is being worked on, with the Religious orders agreeing to set up the Religious Life Safeguarding Service – RLSS. The staff are currently being appointed to this service. For those of you who are PSR's in a Parish run by a Religious Order, you will continue to be recruited, trained and supported by the Central Safeguarding Team. The transition process is likley to take over a year so we will consult you once we are clearer as to the arrangements.

Transition of Safeguarding Commission to be a Sub Group of Trustees, chaired by a Trustee.

In order to implement the Elliot recommendation, the work is underway to make these changes. There is a further meeting of the Safegaurding commission on 15th July, after which point we expect to publish the details of the new arrangements.

Completion of National Questionaire

Thank you to those of you who completed this. We await the collated results being sent to us. We will review them to see what changes we can make to ensure that you are supported as possible.

Amoris laetitia: Family brings light in the world

LOOKING TO JESUS: THE VOCATION OF THE FAMILY

58. In and among families, the Gospel message should always resound; the core of that message, the kerygma, is what is "most beautiful, most excellent, most appealing and at the same time most necessary".50 This message "has to occupy the centre of all evangelizing activity". It is the first and most important proclamation, "which we must hear again and again in different ways, and which we must always announce in one form or another". Indeed, "nothing is more solid, profound, secure, meaningful and wise than that message". In effect, "all Christian formation consists of entering more deeply into the kerygma".


